Anyone can take out a Reynolds pre-paid funeral plan. There is no upper age limit and no medical questions or examinations required. Everyone will be accepted for this plan.

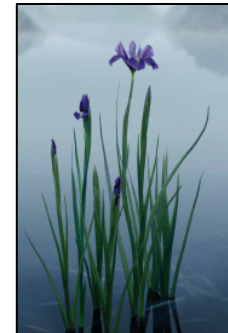
## **Some Questions Answered:**
